4. First-aid measures

Description of first aid measures

General advice	Get medical attention if irritation or other symptoms occur. Show this safety data sheet to the doctor in attendance.
Inhalation	Remove to fresh air. If breathing has stopped, give artificial respiration. Get medical attention immediately. Skin contact	Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Get medical attention if irritation develops and persists. For severe burns, immediate medical attention is required.
